CALL TO ORDER

The meeting was called to order by President Debbie Arnold at 9:12 A.M. followed by introduction of directors, staff and guests.

January 2020 Board of Directors meeting minutes were presented.

March 2020 Board of Directors meeting minutes were presented.

February 2020 Executive Committee meeting minutes were presented.

April 2020 Executive Committee meeting minutes were presented.

It was moved, seconded and approved to accept the 2020 meeting minutes as presented.

FIRE SAFE COUNCIL BUSINESS

- Abbreviated bank statement ending April 30, 2020 was reviewed.
- 2020 SLO FSC Internal Operating budget was discussed.
 - It was moved, seconded and approved to accept the April 2020 Abbreviated Bank Statement and purchases along with the Operating Budget report for the same time period.
- Our application for a credit card has been approved and the card has been issued. We received
 a no interest, no fee and no rewards card with a requirement of the entire balance being paid
 monthly.
- Excess working capital and internal grant program was discussed. It is anticipated we will be in a financial situation to offer grants and scholarships by year end.
- Bylaw and policy revisions have been approved by the Executive Committee and are being
 presented for formal adoption at today's meeting. All documents were provided to board
 members a week in advance for their review and comments.

The following list identifies changes in policies:

- 1) Prudent Reserve Policy was deleted due to the new Working Capital Policy.
- 2) Record Retention Policy was simplified. Retention rates were updated. Archived records are stored at an offsite location.
- 3) Equipment Maintenance Policy was deleted due to SLO FSC not owning any equipment.
- 4) Fuels Modification Policy was edited for ease of understanding.
- 5) Working Capital Policy was created in an effort to maintain a \$400,000 balance to ensure timely payment to vendors.
- 6) Excess Working Capital Policy was created to provide grants and scholarships for those organizations and individuals in our County that have projects with public benefit. Those items must be consistent with the Bylaws and Policies of the San Luis Obispo County Community Fire Safe Council.

It was moved, seconded and approved to accept the April 2020 Abbreviated Bank Statement and purchases along with the Operating Budget report for the same time period.

<u>Direction was given to create binders for all Board Members containing bylaws, policies, rosters, contact information and other SLO FSC information.</u>

- Stacy Korsgaden was invited to join the Board of Directors as an Insurance Industry representative. She comes highly recommended by Ed Waage. Her community involvement and dedication to her industry make her an asset to our organization.

- Mark Elliott with San Luis Obispo County Air Pollution Control District has retired. Carissa Reynolds has been nominated to represent the APCD.
- <u>It was moved, seconded and approved to welcome Carissa Reynolds to the SLO FSC Board of Directors for a term ending January 2021.</u>

NEW BUSINESS / ROUNDTABLE

- Letters regarding fire prevention, forest health and invasive plant work in Cambria were sent to officials in CAL FIRE and the Cambria Community Services District. The letters were sent by Greenspace and the SLO Chapter of the CA Native Plant Society. They were full of misrepresentations, false statements and inflammatory information. Problematic statements were made implying laws and ordinances are not being adhered to. The Executive Committee deemed these letters an urgent matter and directed Business Manager, Dan Turner to respond asking that retraction letters be submitted to all addressees. To date, no retraction letters have been received. David Pierson, Cambria Focus Group, will inform the Cambria Community Services District and the Cambria Focus Group at those groups June meetings.
- Jesse Acosta one of the inventors of Fortify, the bio gel infused with fire retardant, has just sold
 the product to Phos-check. The sale will not affect our use of the product on County roadways
 once we have Caltrans approval. President Debbie Arnold has contacted Assemblyman Jordan
 Cunningham's office in hopes of clearing the roadblocks we are encountering as we try to move
 this project forward.
- Toro Creek Focus Group is very appreciative of the work performed in their area.
- President Debbie Arnold had to leave at 11:00 a.m. for another engagement. Vice President Dan Dulitz assumed the responsibility of chairing the meeting.

- o Add additional parcel level analysis CWPP in Atascadero.
